Waiver of Liability, Assumption of Risk, and Indemnity Agreement.

In consideration of being permitted to participate in any way the group running classes hereinafter called "Classes", I, for myself, my heirs, personal representatives or assigns, do hereby release, waive, discharge, and covenant not to sue Kimberly Brewer, Jen Canoy and Running With the Stars, its designated instructors, guest instructors, students, staff, landlords, property managers, and any and all other parties of liability, from all liability **from any and all claims including the negligence**, resulting in personal injury, accidents, or illnesses (including death) and property loss arising from, but not limited to, participation in the Classes.

Assumption of Risks: Participation in the Classes carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary from one activity to another, but the risks range from 1) minor injuries such as scratches, bruises, and sprains 2) major injuries such as eye injury or loss of sight, joint or back injuries, heart attacks, and concussions 3) catastrophic injuries including paralysis and death.

I have read the previous paragraphs and I know, understand, and appreciate these and other risks that are inherent in the Classes. I hereby assert that my participation is voluntary and that I knowingly assume all such risks.

Indemnification and Hold Harmless: I also agree to INDEMNIFY AND HOLD Kimberly Brewer, Running With the Stars, Jen Canoy, designated instructors, race organizers, guest instructors, students, staff, landlords, property managers, and any and all other parties of liability HARMLESS from any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my involvement in the Classes and to reimburse them for any such expenses incurred.

Severability: The undersigned further expressly agrees that the foregoing waiver and assumption of risks agreement is intended to be as broad and inclusive as is permitted by the laws of the State of Virginia and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
